

Prohibited Behaviors

Sexual Violence: Sexual Assault, Relationship Violence, and Stalking
Harassment and Discrimination based on: Sex, Gender, Gender Identity, Gender Expression, Sexual Orientation, and Pregnancy
Other: Invasion of sexual privacy, sex with person under 18, exposing ones genitals in a public place for purposes of sexual gratification, retaliation, and failure to comply with university orders or sanctions

Consent

Affirmative: silence/lack of protest, in and of itself, doesn't mean consent
Conscious: a person cannot consent if they are incapacitated, or unable to understand due to a mental or physical condition
Voluntary: must be given without coercion, force, threats, or intimidation
Revocable: consent must be ongoing and can be revoked at anytime

Reporting

A report to a Responsible Employee, including to employees at Title IX or UCPD, is not confidential. See section below for confidential resources.

- Responsible Employees:** Any university employee who is not confidential and who receives, in the course of employment, information that a student may have experienced prohibited conduct must promptly notify the Title IX Office.
Faculty, supervisors, Title IX, UCPD, and other specified university personnel [please see UC Sexual Violence and Sexual Harassment Policy (SVSH) for complete list] who, in the course of employment, receive a report of Prohibited Conduct involving any UCLA affiliate, must notify the Title IX Office.
- Title IX Office:** may assist with interim measures and accommodations, provide information about confidential resources, and provide options for addressing reports such as an investigation or alternative resolution.
